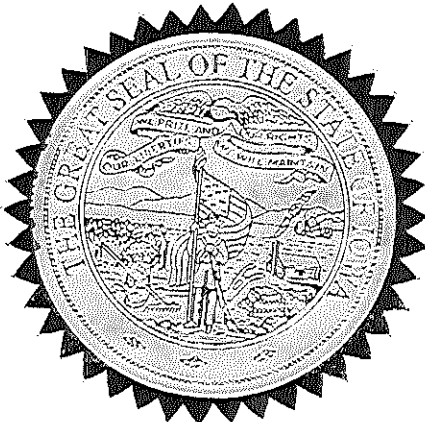

A. Beems, President, filed in the Jones County Recorder's Office on June 24, 1929, in Vol. AG, page 210.
