A parcel of land located in a part of the Fractional Northeast ¼ of the Northwest ¼ of Section 6, Township 88 North, Range 36 West of the Fifth Principal Meridian, Sac County, Iowa, as shown on the Acquisition Plat Exhibit "A" Plat 3 of 3 attached hereto and by reference made a part hereof and more particularly described as follows:




