This easement is subject to the conditions imposed by lowa Code sections 306.24, and 306.45, and to all other conditions imposed by law, and to the right of a utility association, company or corporation to continue in possession of a right of way in use at the time of this conveyance.

(Legal description for Patent of Easement to City of Council Bluffs, Iowa)

A parcel of land located in NW¼NE¼ and NE¼NE¼ of Section 18, T74N, R43W of the 5th P.M., City of Council Bluffs, Pottawattamie County, Iowa, as shown on Easement Plat Exhibit "A" attached hereto and by reference made a part hereof, said parcel is more particularly described as follows:
