A 50 foot wide perpetual easement for pipeline purposes over, under and across that part of the Southwest Quarter of the Northeast Quarter and the Northwest Quarter of the Southeast Quarter of Section 7, Township 74 North, Range 43 West of the 5th P.M., in the City of Council Bluffs, Pottawattamie County, lowa, the northerly and westerly line of said 50 foot wide perpetual easement is described as follows:
