The **STATE OF IOWA**, pursuant to Iowa Code Section 306.45, subject to conditions listed in this easement, hereby conveys a permanent easement for rail purposes to **BNSF RAILWAY COMPANY**, and their heirs, assigns, and successors in interest in real estate in Pottawattamie County, Iowa, described as:

A parcel of land located in the NW¼ NE¼ of Section 18, Township 74 North, Range 43 West of the 5th P.M., Pottawattamie County, Iowa, as shown on Plat of Survey Attachment C-1B, attached hereto and by this reference made a part hereof, more particularly described as follows:

Commencing at the North Quarter of said Section 18, thence S88°15'00"E 1048.63 feet along the north line of the NE¼ of said Section 18 to the Point of Beginning; thence continuing S88°15'00"E 26.13 feet along said north line to a point on the present westerly right of way line of Mosquito Creek; thence S2°31'17"E 100.28 feet along said present westerly right of way line; thence S88°15'00"E 35.62 feet; thence southwesterly 344.41 feet along a 2915.00 foot radius curve, concave westerly and having a chord bearing S2°23'58"W 344.21 feet; thence S6°02'53"W 40.24 feet to a point on said present westerly line of Mosquito Creek; thence S6°10'55"W 293.19 feet to a point on Present westerly right of way line of Interstate Route no. 29; thence N37°05'33"W 91.18 feet along said Present westerly right of way line of Interstate Route no. 29; thence N6°10'55"E 226.80 feet; thence N6°02'55"E 39.80 feet; thence northerly 440.23 feet along a 2852.50 foot radius curve, concave westerly and having a chord bearing N1°21'46"E 439.80 feet to the Point of Beginning, said parcel contains 42,763 square feet or 0.98 acre.

CONDITIONS: Consideration for the grant of this easement pursuant to lowa Code section 306.45 is set forth in the certificate of the **Right of Way Director of the lowa Department of Transportation** filed with the State Land Office.
