The STATE OF IOWA, pursuant to Iowa Code section 306.45, subject to conditions listed in this easement, hereby conveys a permanent easement for constructing, reconstructing, operating, maintaining and removing wires and cables for the transmission and distribution of electric energy and for communications and electrical controls, including the necessary appurtenances, poles, wires, guys, anchors and switchgear, under and on the surface of the ground, together with the right of ingress and egress and the right to clear and keep clear from the property within the easement any buildings, plantings or other obstructions as may be necessary for the purposes for which this easement is granted, to Interstate Power and Light Company, an Iowa corporation, and their heirs, assigns, and successors in interest in real estate in Marshall County, Iowa, described as:

**Property Description:** Lot 1 of 4, located in the Northeast Quarter (NE1/4) of the Southwest Quarter (SW1/4) of Section 35, Township 84 North, Range 18 West, City of Marshalltown, Marshall County, Iowa, EXCEPT lands conveyed to the City of Marshalltown on November 22, 1971 as Instrument No. B230187 (PID 07-35-332-005)

Easement Area(s) Description: The North and Northwesterly ten feet (10') of Lot 1 of 4, lying westerly of the centerline of S. First Street extended. Also, an Easement Area ten feet (10') in width, being five feet (5') each side of the following described reference line: Commencing at the centerline of S. 1st Street and North Line of Lot 1 of 4; thence westerly along said North Line of Lot 1 of 4, a distance of 195 feet; thence south 10 feet to the Point of Beginning; thence continuing south 70 feet, more or less, to the YMCA building, and there terminating. Said Easement Area(s) being further depicted on the attached Exhibit "A".

**CONDITIONS**: Consideration for the grant of this easement pursuant to lowa Code section 306.45 is set forth in the certificate of **the Right of Way Director of the lowa Department of Transportation** filed with the State Land Office. This easement is subject to the conditions imposed by lowa Code sections 306.24, and 306.45, and to all other conditions imposed by law, and to the right of a utility association, company or corporation to continue in possession of a right of way in use at the time of this conveyance.
