## STATE LAND OFFICE

The STATE OF IOWA, subject to conditions listed in this patent, hereby conveys to Robert A. Van Meeteren Revocable Trust and Cheryl Diane Van Meeteren Revocable Trust, real estate in O'Brien County, lowa, and more particularly described as follows:

A plat of survey showing a part of the Northwest 1/4 of the Southwest 1/4 and a part of the Northeast 1/4 of the Southwest 1/4 of Section 28, Township 97 North, Range 42 West of the Fifth Principal Meridian, O'Brien County, Iowa, as shown on the Plat of Survey, attached hereto and by reference made a part hereof and more particularly described as follows:

Commencing at the Northeast Corner of the Southwest 1/4 of said Section 28; thence South 00°50′28" West, 620.39 feet (189.094m) along the East line of said Southwest 1/4; thence North 89°04′19" West, 439.32 feet (133.906m) to the Point of Beginning and on the North line of a parcel of land conveyed by a certain Warranty Deed, executed by Iva Jane Frohwein and Ethel Hulst on November 7, 2002 and filed for record in the Office of the O'Brien County Recorder on November 21, 2002 in Book 111 of Land Deeds on Page 590; thence running on the boundaries of said parcel of land for the following three courses, North 89°04′19" West, 1097.35 feet (334.473m) to the Northwest Corner of said parcel; thence South 00°57′29" West, 697.98 feet (212.743m) to the Southwest Corner of said parcel, said point being on the South line of the North 1/2 of the Southwest 1/4 of said Section 28; thence South 88°42′59" East, 1054.72 feet (321.480m) along said South line; thence North 04°25′20" East, 705.72 feet (215.105m) to the Point of Beginning, containing 17.32 acres.


