STATE LAND OFFICE

The STATE OF IOWA, pursuant to lowa Code section 306.45, subject to conditions listed in this easement, hereby conveys a permanent easement for the purpose of constructing, reconstructing, inspecting, repairing, replacing, enlarging, maintaining, removing, accessing and operating a water main together with necessary appurtenances thereto, both above and below ground, under, over, and through and across said Permanent Easement area to City of Council Bluffs, lowa for the use and benefit of the Board of Water Works Trustees of the City of Council Bluffs, lowa and their heirs, assigns, and successors in interest in real estate in Pottawattamie County, lowa, described as:

See Exhibit "A", Plat of Survey Pages 1 of 2 and 2 of 2 attached hereto and by this reference made a part hereof.

The Grantee for itself, its personal representatives, successors in interest, and assigns, as a part of the consideration hereof, does hereby covenant and agree, as a covenant running with the land, that in the event facilities are constructed, maintained, or otherwise operated on the said property described in this easement for a purpose for which a Department of Transportation program or activity is extended or for another purpose involving the provisions of similar services or benefits, the Grantee shall maintain and operate such facilities and services in compliance with all other requirements imposed by or pursuant to Title 49, Code of Federal Regulations, Department of Transportation, Subtitle A, Office of the Secretary, Part 21, Nondiscrimination in Federally-assisted programs of the Department of Transportation-Effectuation of Title VI of the Civil Rights Act of 1964, and as said Regulations may be amended.

That in the event of breach of any of the above nondiscrimination covenants, the lowa Department of Transportation, acting for the State of Iowa, shall have the right to re-enter said land and facilities thereon, and the above described lands and facilities shall thereupon revert to and vest in and become the absolute property of Iowa Department of Transportation, acting for the State of Iowa, and its assigns.

CONDITIONS: Consideration for the grant of this easement pursuant to lowa Code section 306.45 is set forth in the certificate of **the Right of Way Director of the lowa Department of Transportation** filed with the State Land Office. This easement is subject to the conditions imposed by lowa Code sections 306.24, and 306.45, and to all other conditions imposed by law, and to the right of a utility association, company or corporation to continue in possession of a right of way in use at the time of this conveyance.


