S35°23'09"E 21.23 feet to a point on the southerly right of way line of the lowa Interstate Railroad; thence S56°54'56"W 59.40 feet along said southerly right of way line; thence N36°59'57"E 62.27 feet to the Point of Beginning, said parcel contains 630 square feet or 0.01 acre.

The State retains the right of entry thereon for the purpose of constructing and maintaining the right of way fence. The fence shall be maintained for vehicle access control purposes only. The State will be held blameless and without liability for fencing private property or maintaining the same. The buyer may pasture against said fence at their own peril and the State will be held blameless and without liability for fencing private property or maintaining the same to restrain livestock.
