Thank you for your letter expressing your concerns about the 2010 Census counts for Asbury, Iowa as part of the Count Question Resolution (CQR) Program.

We reviewed the documentation you provided, in conjunction with the official 2010 Census records, as part of our research to resolve your question(s). Our research found an error in the geographic assignment of housing units and/or group quarters related to Asbury. The updated census tract and block counts will soon be available at www.census.gov/prod/cen2010/notes/errata.pdf.
