

This letter is in response to your concerns about the 2010 Census counts for Maharishi Vedic City as part of the Count Question Resolution (CQR) Program. We assigned **Case Number 90001** to your inquiry.

We reviewed the documentation you provided in conjunction with the official 2010 Census records as part of our research to resolve your questions. Our research found an error in the geographic assignment of housing units/group quarters related to Maharishi Vedic City. The updated census tract and block counts will soon be available at [www.census.gov/prod/cen2010/notes/errata.pdf](http://www.census.gov/prod/cen2010/notes/errata.pdf).

Census counts used for Congressional apportionment, legislative redistricting, and the 2010 Census data products will remain unchanged. The Census Bureau will include the corrections in the errata information, which will be available via the Internet on the *American FactFinder* system, and use them specifically to modify the decennial census file for use in annual postcensal estimates beginning in December 2012.
