

Things You Need to Know on Election Day

Your Ballot, Your Vote

Don't panic if you registered to vote but your name is not on the list. Get help from an election official to make sure your vote is counted. You may be directed to another polling place or given a provisional ballot.

Identification—Bring ID With You

You will be asked to show identification. Bring your Iowa Driver's License, Iowa Non-operator ID, U.S. Passport, U.S. Military or Veterans ID, Iowa Voter Identification Card or Tribal ID Card/Document.

Writing on the Wall

Look at the signs at the polling place for directions on how to use the voting machines, a list of your voting rights and instructions for filing a complaint if your rights have been violated.

When in Doubt, Ask

Election officials are there to help you. They'll show you how to use the machines and give you a provisional ballot if you need one.

Election Day Registration

Iowa law allows you to register to vote on election day at the polling place for the precinct in which you currently live. To do so, you must prove identity and residency. The easiest way to do so is using your non-expired Iowa driver's license or non-operator ID card with your current address printed on it. Another registered voter of your precinct may also attest to your identity and residence.

Voting with Assistance

If you need help marking your ballot because of a disability or because you cannot read English, any person you choose may help you, except your employer, your employer's agent, an agent of your union, or an officer of your union. If you want help from the election officials, one person from each political party will help you. You will be asked to sign a form to show that you asked for assistance.

Deadlines for Registering to Vote

The voter registration deadline is 10 days before general elections and 11 days before any other election.

Voter Registration Acknowledgment

You will receive an acknowledgment of a your voter registration within 14 days. If you do not, call your county auditor. Be ready to tell the auditor when and where you completed the registration form and to whom you gave the voter registration form. If you do not have a current Iowa driver's license or non-operator ID, this acknowledgement will include an Iowa Voter Identification Card for voting purposes.

Voter Registration is Permanent

After you register to vote, you do not have to register again unless you move to a new address. However, your registration will be cancelled if you are convicted of a felony or judged to be incompetent to vote by a court.

Voter Registration Information

You may apply to register to vote when you apply for assistance. This agency is required to offer you an opportunity to register to vote.

To register to vote in Iowa, you must:

- Be a citizen of the United States
- Be a resident of Iowa
- Be at least 17 years old
- Not have been convicted of a felony (or have had your rights restored by the Governor, including through Executive Order, after a felony conviction.)
- Not currently be judged by a court to be “incompetent to vote”
- Give up your right to vote in any other place

Assistance

If you would like assistance in filling out the voter registration form, we will help you. The decision whether to seek or accept help is yours. You may fill out the application form in private. You may take the registration form with you to fill out later and return it to this office or your county auditor.

Benefits

Applying to register or declining to register to vote will not affect the amount of assistance that you will be provided by this agency.

Privacy

If you register to vote, the name of the office where you turned in the registration form will be kept private. If you do not register to vote, this fact will also be kept private. The information provided on this form will be used only for voter registration purposes.

Use this form to apply to register to vote or to make changes to your current voter registration. Use a pen and print neatly.

Required Information

- ID number
- Date of birth
- Sex
- Name
- Address
- Signature

If you do not include the required information, your registration cannot be processed.

ID Number

Your Iowa driver’s license or non-operator ID number is required if you have one. If you don’t have one of these, put the last 4 digits of your Social Security Number. Iowa Code section 48A.11 requires the state to ask for these numbers on this form.

If your ID number cannot be verified, you will be required to show proof of identification and residence before voting.

Driver’s license, non-operator ID, and Social Security Numbers are not printed on voter registration lists sold to candidates and others.

Read the form carefully before you sign it.

Mail the completed form to your county auditor.
