Draw Names - Non-Partisan Office Ballot Order Auditor draws the names of candidates for non-partisan offices (county hospital trustee, soil and water commissioner, agricultural extension council, and township offices) to determine the order in which the names of those candidates will appear on the ballot. Notify NPPO candidates if drawing must be held If multiple nominations for a single office are received from candidates for the same NPPO, lots will be drawn to determine which candidate will have the NPPO's name appear with the candidate's name on the ballot. The other candidate(s) will appear as "Nominated by Petition." The auditor must notify candidates of the time and date of the drawing.
