

The Precinct Atlas[®]

Reporting Functionality

The Precinct Atlas[®] reporting module can be accessed on each precinct master computer by logging into the computer as an administrator (username = admin, password = admin) and clicking on the “Reports” drop down menu as illustrated below. To access all of the reports for a precinct, you must enter your initials, choose “Master”, whether to print labels and then click “OK” instead of “Bypass”.



Election Admin Reports



1. Polling Place Listing

This report lists the polling places imported from IVOTERS for the election. The polling code is the IVOTERS assigned polling place code. Depending on how you name your polling codes in IVOTERS, you may internally refer to these locations differently for certain elections, depending on whether you consolidate precincts for the election. (e.g. school elections) The Int. Poll # is the number the Precinct Atlas internally assigns to each polling place.

2. Split/ Ballot/ Polling Listing

This report lists the voter’s county of residence, the split code the voter is assigned to, the ballot type assigned to that split code in IVOTERS, and the polling place that split code is assigned to in IVOTERS for the election.

3. Absentee Ballot Listing **NEW**

This report is a list of all absentee voters loaded into Precinct Atlas from IVOTERS. It is a good way to double check that you have the most recent absentee file loaded. The total number of absentee voters can be seen on the last page.

4. Countywide Listing

This report lists all voters in your county, and also includes voters in areas of other counties for which you are the control county auditor (e.g. school elections).

5. Precinct Guide

This report is a list of streets and the polling place to which they are assigned. Currently, this report lists the general election precincts only so you should either generate a separate precinct guide from IVOTERS or provide PEOs with a conversion chart to serve as a Precinct Atlas[®] backup for the school and city elections until a modification to the program can be made.

6. Non-Primary/ Primary Election Register

The election registers can be printed either landscape or portrait. These election registers do not currently contain the voter’s eligibility statement so they cannot be used as an eligibility slip substitute at this time. The registers do include a barcode so the information contained on them can be scanned and uploaded into IVOTERS after the election if necessary.

7. **New Voter (EDR) Listing**

This report contains a list of voters who registered for the first time in the county at a precinct during the election. The report contains critical voter registration information as well as a date the change occurred.

8. **Voter Changes (NON-EDR) Listing**

This report contains a list of voters who changed registration information at a precinct on election day. These are voters who were already registered to vote in the county but updated voter registration information. The original information is in regular print on the top row and the new information captured by Precinct Atlas[®] is in bold, directly below the original information.

9. **Voter Surrendered Ballot Report *NEW***

This report lists the voter ID numbers and names of voters that surrendered absentee ballots at a precinct.

10. **Attested Voter Report *NEW***

This report lists the names of voters that were attested for at a precinct, along with the name and voter ID number (if any) of the voter that attested for the new voter.

11. **Challenged Voter Report *NEW***

This report lists the voter ID numbers and names of voters that were challenged by observers or other voters at the polling place. The report also includes the challenger's voter ID number and name. Precinct election officials are not required to fill out a challenge form and will not be listed on this report.

12. **Voter Assistance Report *NEW***

This report lists the voter ID numbers and names of voters that requested assistance at a precinct.

13. Vote Type Tally Report

This report can be generated in two ways. It can be generated for ballot balancing purposes by the precinct election officials in the precinct on election day from the “Election Day” drop down menu at the top of the screen. It can also be generated from the precinct master computer after the election from the menu depicted above. This report lists the number of ballots voted in the precinct during the day, broken down into categories, i.e. “Change” = voters who were already registered in the county but moved into the precinct; “Provisional” = voters casting a provisional ballot; “Regular” = voters already registered in the precinct.

14. Ballot Type Tally Report

This report contains the number of each type of ballot voted in the precinct, including “Regular” ballots cast, “Change” ballots cast by voters were already registered to vote in the county and who submitted an address change in the precinct during the election and “Provisional” ballots cast in the precinct.

15. Bar Code (Regular) Vote Report – Regular Votes Only

This report contains barcodes representing the voter IDs of voters who were already registered to vote in the precinct. You can use this to credit voters in Election Management > Process Election Registers, by scanning the barcodes *however*, this file can also be automatically exported after it is generated, eliminating the need to do any scanning. The export function automatically creates a text file of the voter IDs. When you click “Export” after generating this report for each precinct, the text file is saved to the computer’s C: drive in the “Precinct Atlas[®]” folder. The text file is named <PrecinctCode>-Reg. The text file can then be saved to a flash drive and imported into IVOTERS. Alternatively, if you have the capability to connect to IVOTERS using the precinct master laptop at the auditor’s office, you can log into IVOTERS and upload the text file directly from the precinct’s master computer. See IVOTERS import instructions for additional information about the voter credit file importing function.

16. Bar Code (Change) Vote Report—Non-EDR Change Votes Only

This report contains barcodes representing the voter IDs of voters who were already registered to vote in the county but moved into the precinct on election day and updated their voter registration information. These records cannot be automatically exported; however you can use this report in conjunction with your Election Voter Changes Report to easily credit voters who moved into the precinct by completing the following steps:

- a. Use the voter registration form(s) from the precinct to update the voter address(es) in IVOTERS first. Use transaction source 07- In Person (Do not use 15—EDR).
- b. Then, go to Election Management > Process Election Register and open the election register of the precinct for which you generated this report.
- c. Scan the “Bar Code (Change) Vote Report—Non-EDR Change Votes Only” records. As you scan the barcodes, the voters on that report will receive polling place vote credit in the precinct where they re-registered and voted on election day.

17. Regular Vote Type Detail Report

This report lists the names and voter ID numbers of voters who cast “Regular” ballots in the precinct on election day. The report also lists the ballot style the voter should have been given. This is the same ballot style assigned to the voter’s split for the election in IVOTERS. For instructions on modifying ballot style identifiers in IVOTERS, please contact the IVOTERS help desk.

18. Change (EDR) Vote Detail Report

This report lists the names and a Precinct Atlas[®]- assigned voter ID number for any voters that registered on election day. The report also lists the ballot style the voter should have been given. This is the same ballot style assigned to the voter’s new split for the election in IVOTERS. For instructions on modifying the ballot style identifiers in IVOTERS, please contact the IVOTERS help desk.

19. Change (NON-EDR) Vote Detail Report

This report lists the names and voter ID numbers of voters who were already registered in the county and submitted a change of address at their new precinct on election day. The report lists the voter ID number and also lists the ballot style the voter should have been given. This is the same ballot style assigned to the voter’s new split for the election in IVOTERS. For instructions on modifying the ballot style identifiers in IVOTERS, please contact the IVOTERS help desk.

20. Provisional Vote Detail Report

This report lists the names and voter ID numbers (if any) of voters who cast provisional ballots in the precinct on election day. The report also lists the ballot style the voter should have been given. This is the same ballot style assigned to the voter's split for the election in IVOTERS. For instructions on modifying the ballot style identifiers in IVOTERS, please contact the IVOTERS help desk.

21. Provisional Vote with Absentee Report ***NEW***

This report lists the names of voters that were issued absentee ballots and were required to cast a provisional ballot.

22. Voter Termination Listing Report

This report lists the names of voters who were "Terminated" during the day in the precinct. "Terminated" voters are those who the precinct election official began processing but left the precinct without voting or voters whom the precinct election official chose in error. This report also contains the voter ID number and the reason the voter processing was "terminated" on election day.

23. Precinct Official Log Listing Report

This report is a list of individuals that logged into each computer since the election was created or the backup file was restored. It contains the name of the individual that logged in, including the permissions used to access the program (i.e. admin or worker). It also lists the times each individual logged in and logged back out.




24. Overall Vote Type Tally Report

This report lists the three different types of ballots that can be cast (i.e. Regular, Change and Provisional) on one report that can be used for reconciling ballots returned from the precinct, voter changes and the number of provisional ballots cast in the precinct.

Post-election Retention Reports

This is a new menu containing several reports that should be generated and printed for each precinct after each election. These reports should be kept for the 6/ 22 month retention period required by Iowa law.
