Discussion regarding on-line VR, uniformity of county systems, practices in other states, mechanisms to obtain a "wet" signature.

Motion by Commissioner Carol Olson, second by Commissioner Chad Olsen that the VRC directs the staff of the State Registrar of Voters to analyze the potential use of electronic signatures for purposes of voter registration, specifically for in-county moves of registered voters. Additionally, the State Registrar's staff shall review appropriate safeguards that would ensure the security of potential electronic voter registration records. The Registrar's staff shall report its findings to the VRC at its meeting during the 4<sup>th</sup> quarter of 2018. Roll call vote: Olson, Aye; Bonham, Aye; Geiken, Aye; Olsen, Aye. Motion passed.
