Accessible Voting in Iowa

Federal and state laws require polling places to be accessible to individuals with disabilities. Additionally, every polling place is equipped with a ballot marking device to allow persons with disabilities to vote privately and independently.

Voting with Assistance

If special assistance is needed, you may ask for help from a precinct election official at the polls, or you may have someone assist you. You may choose anyone except your employer, your employer's agent, or an officer/agent of your union.

You will be asked to sign a form stating that you asked for help. If you are not physically able to sign the forms, you can use a rubber stamp or mark to sign. You may also ask for assistance or have someone sign the reform on your behalf as long as it is in your presence and with your permission.

Curbside Voting

If you are unable to enter the polling place building, you may vote curbside. Two precinct election officials, one from each political party, will bring voting materials to you in your car, where you can then mark your ballot. Setting up curbside voting can be done either by contacting your county auditor's office or by having an able-bodied assistant ask inside the polling location.

Accessible Voting Machines

Each polling place has an accessible voting machine. These machines are available to assist voters with reading or marking their ballot. Features on the machine such as a touch screen, an audio component, and/or a sip and puff element to select their candidates. The device will mark their ballot according to their selection.

Voting with a Conservator of Guardian

Those who have a conservator or guardian can still vote unless a judge has specifically said in a court ruling that they may not vote.

Absentee Voting in Iowa

Voting at polls can present a unique set of challenges to people with disabilities. It is the intent of federal and state law to ensure that voters with disabilities are fully able to exercise their voting rights at the polls.

How can I vote absentee?

An absentee ballot may be requested by printing a request form from the **sos.iowa.gov/disabilities website**. Once signed, mail the request form to your county auditor. An absentee ballot will be mailed to you. After you have completed your ballot, mail it back to your county auditor.

How can I vote absentee and in person?

Beginning 20 days before the General Election, you may vote in person at your county auditor's office. This might be helpful if you need a little extra time or personalized assistance. Some counties allow you to use satellite voting locations.
