Iowa Code section 202B.402 provides penalties for failure to timely file this Report and for the filing of false information.

Instructions for Filing the Contract Feeder's Annual Report for Calendar Year 2025 by March 31, 2026.

WHO MUST FILE – Iowa Code § 202B.102(5) and § 202B.301.

A contract feeder must file this Annual Report with the Secretary of State on or before **March 31** of each year on forms supplied by the Secretary of State.

“Contract feeder” means a person owning in the applicable reporting year, as provided in section 202B.301, more than two thousand five hundred swine or five thousand head of poultry, if the swine or poultry are subject to a contract or contracts for care and feeding by a person or persons other than the owner on land which is not owned, leased, or held by the owner.

SIGNING THE REPORTS – Iowa Code § 202B.303.

Reports by **corporations** shall be signed by the president or other officer or authorized representative. “Corporation” means a domestic or foreign corporation subject to Iowa Code chapters 490, 504, 497, 498, 499, 501 or 501A.

Reports by **limited liability companies** shall be signed by a manager or other authorized representative. “Limited liability company” means a limited liability company subject to Iowa Code chapter 489.

Reports by **limited partnerships** shall be signed by the president or other authorized representative of the partnership. “Limited partnership” means a partnership subject to Iowa Code chapter 488.

Reports by **individuals** shall be signed by the individual or an authorized representative.

PENALTIES – Iowa Code § 202B.402.

Failure to timely file a report or the filing of false information is punishable by a civil penalty not to exceed one thousand dollars.

NOTE: The reports by contract feeders required under section 202B.301 shall be confidential except to the Attorney General and the General Assembly for review and appropriate action when necessary. *Iowa Code § 202B.304.*
